PRESENTATION – Black Hawk County Public Health Workforce Development Survey: Anjali Deshpande, PhD, MPH and Anya Morozov, University of Iowa College of Public Health summarized the results from their Learning Culture Assessment at the Health Department. The study showed a mission-driven staff with good community connections, team building, leadership support and health benefits, but stressed the need for better compensation, opportunities for advancement and on-the-job learning systems in order to attract and retain qualified, competent and committed employees.

RECEIVE PROJECT UPDATES FROM DEPARTMENT HEADS/ELECTED OFFICIALS. County Engineer Cathy Nicholas said many gravel roads are in poor condition due to recent rains. Human Resources Director Amanda Fesenmeyer said the Classification and Compensation consultants would hold a management team meeting on January 18 and would personally meet with the supervisors on January 24. Consolidated Communications Center (CCC) Director Judy Flores asked that a work session be held to discuss the communication from the supervisors that they wished to hold off on switching funding of the CCC from donations by participating municipalities to a county general fund levy. The supervisors said they wish to hold a work session as soon as possible.

Nicholas said the county has only 2000-3000 linear feet of sidewalks and thus has little experience with their maintenance, hence the agreement to have the city effect the necessary repairs at the intersection of Juniper Drive and Oak Ridge Drive.
