Kurtenbach moved the following RESOLUTION seconded by Brandt that the LOWEST RESPONSIBLE BID received Oden Enterprises, Wahoo, NE (letting held January 13, 2026, 9:05 a.m.) for Project L-3011, Steel Materials for Oxley Road Bridge with a total bid of \$38,134.12 (Engineer's Estimate of \$31,970.00) be awarded and direct the Chair to sign resolution authorizing the County Engineer to sign the contract and to receive and place on file the Contractor's Bond and Certificate of Insurance as recommended by Catherine Nicholas, County Engineer.

- **District 1:** 4-year term
- **District 2:** 2-year term
- **District 3:** 2-year term
- **District 4:** 4-year term
- **District 5:** 4-year term

Moved by Brandt, seconded by Hall to direct the County Auditor to advertise for a PUBLIC HEARING/BID OPENING to be held at 9:05 a.m. on February 17, 2026, in Board Room 201 of the Black Hawk County Courthouse, 316 E. 5th Street, Waterloo, Iowa on the proposed Fiscal Year 2026 pavement markings project in various locations throughout Black Hawk County. Motion carried.

Moved by Schwartz, seconded by Hall to direct the County Auditor that the TRAVEL REQUEST submitted by Ritch Kurtenbach, County Supervisor, be approved and that the Chair be directed to sign for same: in the amount of \$851.00 to attend the ISAC Spring Conference, March 11-13, 2026. Motion carried.

Brandt moved the following RESOLUTION seconded by Hall that any advisory committee, task force, or working group created by the Black Hawk County Board of Supervisors constitutes a "government body" under Iowa Code 21.2 and must comply with all requirements of Iowa Code Chapter 21, including open meetings, public notice, and minutes effective January 20, 2026

Discussion of new logo placement on the courthouse exterior windows and other county building locations. Gabbi DeWitt, Marketing Coordinator, presented images of signage for the main entrance and all three conference rooms.

WORK SESSION

Discussion – Consideration of all aspects of the FY27 Black Hawk County Budget. FY27 department budget presentations included: **Conservation – Mike Hendrickson**, reporting revenue up 2.3% and operating expenses up 1%, \$580,000 requested in capital improvements for park and trail projects; **Human Resources – Amanda Fesenmeyer**, noting an 88% retention rate for FY25 and

increased budget requests for training, professional services, and support for wellness programs and employee incentives; **Treasurer - Lynda Hintzman**, reporting revenue up 18% and operating expenses down 1.8% with DOT providing a queuing system eliminating the need for an individual contract; and **Roads/Engineer - Catherine Nicholas**, reporting that FY27 revenue exceeds expenses, with revenue up 1.84%. Operating expenses increased due to professional services, fuel, materials, and safety items, while capital requests are down 44%.


ANY REPORTS OR INFORMATION FROM THE BOARD
