Update and discussion on 6843 E. Washburn Road no rise requirement per the Iowa DNR Flood Insurance Program (see minutes of July 11). Black Hawk County Zoning Administrator Seth Hyberger said "no rise" certification is required for any structure built on a flood plain to certify that the structure won't increase the water level somewhere else. He said that the Schultes built a garage without a permit or a floor plan approval, and the only way they can keep the garage is if they can get a no rise certificate, take it to the Board of Adjustment, and get the Board to approve a variance, which it seldom does in his experience. He granted that the no rise certification is a costly process and that it might be for naught if the Board of Adjustment is unsympathetic, but he said that the law is clear. Daniel Schulte said that other people put up buildings without permits and it wasn't fair to single out one person. Hyberger said that he doesn't go out looking for violations but if they are brought to his attention he will investigate. He said one option available to the Schultes is to sell the garage and have it moved off the property.

Discussion – review of the Draft request for proposal (RFP) for Healthcare (Medical and Mental Health) Services for the Black Hawk County Jail. Jail Superintendent Captain Nathan Neff said he contacted Bremer County at Trelka's request and found that while inmate health costs are much less than they are at Black Hawk, only about 10 or 15 of their 50 inmates are local, with the rest being inmates from the federal government, which pays for their health care. He gathered information from Pottawattamie County, which has a direct-supervision jail like Black Hawk with a similar population. They employ their own health staff, which currently works 5 am to 11 pm, but which they find inadequate, so that they are planning to expand to full time. They have mental health services for ten hours a week unlike 40 hours for Black Hawk, but they also plan to expand that, so that he feels their \$1.15 million budget will be similar to Black Hawk's when those changes are made. He said that a consent decree in 1999 citing the county with a lack of onsite medical and mental health care was largely responsible for the level of care currently at the jail.

Laylin asked about changes in the RFP from current practices. Neff said that currently there is a doctor or nurse practitioner on site nine hours a week, and the RFP changes it to six hours. He said the Black Hawk RFP was largely based on that used last year by Polk County, which employed a team of attorneys in drawing theirs up. He felt that the county could not realistically reduce the services it now provides for a very vulnerable population. He said if the jail keeps mentally ill inmates regulated with their medication, they are safer when they leave jail as well as being safer in jail, and less prone to suicide, noting that suicide incidents are very costly for the county. Little asked if he checked with other NaphCare clients around the country. Neff said he did not, because he wanted the bidding to be open to all possible vendors. Little asked if other counties experienced their vendor coming back for more money than contracted. Neff said that this occurred with Polk County, which accepted a 25-30% increase. He said there are few vendors in this business, some having bought others out, that some vendors cater to larger and some to smaller jails, and Black Hawk typically falls between the two. The supervisors agreed to have the RFP on the agenda for action in one week.

Seth Hyberger of Planning and Zoning said the request was unanimously approved by the Planning and Zoning Commission.
