Nicholas said the city wishes the county to contribute \$350,000 for the project, which she determined was reasonable. There is \$325,000 budgeted in FY24, and she will budget \$25,000 more for it in FY25.

BE IT HEREBY RESOLVED to approve the ARTICLES of AMENDMENT to CONSOLIDATED PUBLIC SAFETY COMMUNICATIONS 28E AGREEMENT as approved by the Oversight Board on 28th day of June 2023, by and between Black Hawk County; the City of Waterloo; the City of Cedar Falls; the City of Evansdale; the City of Hudson; the City of LaPorte City; the City of Dunkerton; and the City of Gilbertville ("Parties").

Laylin noted that the supervisors had unanimously approved the amendment in determining the county's single vote on the Oversight Board.

Schwartz moved the following resolution seconded by Hall.

BE IT HEREBY RESOLVED to approve the agreement between Black Hawk County and HKG Solutions for online benefit enrollment software at an annual cost of \$21,260 for year one, \$17,760 for year 2, and \$17,760 for year three as recommended by Amanda Fesenmeyer, HR Director, and Perspective Consulting, contingent on the approval of contract language by Assistant County Attorney Mike Treinen.

Fesenmeyer said that HKG Solutions was amenable to suggested changes in the agreement by Treinen. Little said action should be tabled for a week so that Treinen could evaluate the new language. Other supervisors preferred to append a contingency clause.

AYES: Hall, Schwartz, Trelka, Laylin.

NAYS: Little. Resolution adopted.

Moved by Schwartz, seconded by Hall to direct the County Auditor to advertise for a public hearing to be held at 9:05AM on Tuesday, August 22, 2023, in Board Room 201 of the Black Hawk County Courthouse, 316 E. 5th Street, Waterloo, Iowa on the proposed purchase of two (2) Single Axle Dump Trucks and one (1) Tandem Axle Dump Truck for the Black Hawk County Engineer's Department.

Nicholas said they are seeing only one bidder for the trucks, so changes are being made in the bidding process, and she'll come back later with bids for other vehicles. Motion carried.

Moved by Hall, seconded by Schwartz that the REAPPOINTMENT of Jerry Hageman as a representative for the County Recorder Office on the Black Hawk County Compensation Board be approved, effective July 1, 2023.

Moved by Schwartz, seconded by Hall that the REAPPOINTMENT of Steve Brustkern as a representative for the County Sheriff's Office on the Black Hawk County Compensation Board be approved, effective July 1, 2023.

Discussion - Local option sales and services tax (LOSST) referendum anticipated for November 7, 2023. County Auditor Grant Veeder said that with the City of Waterloo initiating the referendum, the Board has the responsibility to set the date of the election, which could be held concurrently with the City/School Election on November 7 if it sets the date by August 15. The Board and the cities in the county then have until September 1 to determine ballot language for how they will use their portion of the tax. The county currently uses 50% for property tax relief in the Rural Fund and 50% for roads and bridges. The tax currently has a 10-year sunset provision which causes it to expire December 31, 2025. Trelka said he didn't see a need for a sunset, and the county needed money for dispatch and other things. Schwartz said he was inclined to not have a sunset and wanted to know what the cities think. He wondered what would be the effect of putting more toward roads. Nicholas gave a presentation showing that the tax had enabled the addition of 80 miles of roadway, which are in good condition now but will need attention soon. She hoped that the Board would still use at least half of the county's portion of the tax for roads and bridges and perhaps consider increasing the amount to 60%. Little asked if Secondary Roads still erects signs saying roads were paid for by local option taxes, as the Board requested. Nicholas said they haven't done so for about five years. Schwartz said he wanted to consider raising the roads and bridges portion to 60%, noting that it is a point of pride to see how secondary roads often improve when one crosses the county line into Black Hawk County. Hall asked how much funding has increased each year. Finance Director Michelle Weidner said the amount has doubled since 2008, and more can go directly to roads now that interest on bonds has been paid off. She said that raising the roads and bridges share to 60% would affect other Rural Fund expenditures such as Uniformed Patrol and Dispatch. Little said that when he was first on the Board, rural residents argued that city dwellers used county roads but didn't pay for them, so the Board agreed to use some of the option tax for tax relief. Nicholas said that the heavier weight limits that are being approved by the legislature are for the benefit of farmers, whose heavier loads are putting the most stress on the roads and bridges.

Discussion/Possible Board Action – American Rescue Plan Act – County projects. Treinen said the ARPA Committee will no longer have scheduled biweekly meetings and will meet as necessary. Laylin said if there is no objection, this item will be dropped from the agenda until needed.
