Evan Leroy Hultman, "American Lawyer"

Entered Military Service in 1943 as Private in the Infantry; Discharged 1946 with rank of Captain; Served as Battalion Commander oversea in the 19th Infantry, Commander of the 450th Strategic Military Intelligence Detachment. Served as the Reserve Assistant to the Judge Advocate General of the 103rd Support Brigade. Promoted to Major General February 4, 1980, as Commanding General of 103rd COSCOM. Assigned Commanding General of the 88TH United States Army Reserve Command. In November 1984, General Hultman was awarded the Distinguished Service Medal by the President of the United States.

Military Occupation: Infantry Officer, Judge Advocate General

Additional Info: Inducted into the Hall of Fame of the United States Army Infantry in 1984. Awarded Distinguished Service Medal and various other personal awards.

This Picture Upset Both Parties

WASHINGTON, D. C.—An evening cruise on the Potomac by Representative Fred Schwengel (Rep., Ia.) with Attorney General Robert F. Kennedy has had repercussions in both political parties.

After that Aug. 5 cruise, Schwengel proposed that Kennedy invite the Iowa attorney general, E. Van Hultman, a Republican, to come to Washington for a conference on civil rights.

Although Schwengel has been critical of the general operations of the Kennedy administration, and specifically critical of Robert Kennedy, they were reported to have been in genial rapport during the two-hour cruise.

Schwengel has been almost as outspoken on the civil rights issue as the attorney general, and both are impasioned in believing they are carrying out the ideas of Abraham Lincoln.

Bypassed Hughes
Some Iowa Democrats are bitter because Kennedy invited Iowa's Republican attorney general to Washington and passed by Iowa Gov. Harold E. Hughes.

Hughes, a Democrat and an outspoken civil rights advocate, has never been invited to Washington for the prestige build-up of a conference and pictures with either the

attorney general or the President.

Governor Hughes was not consulted as to whether the Iowa Republican attorney general should be brought to Washington, and he is reported to have expressed his irritation to high Kennedy administration officials.

Hughes is reported to consider the invitation to be directly beneficial to Hultman, who is expected to be a candidate for the Republican gubernatorial nomination in 1964.

Other Iowa Democrats consider the invitation to Hultman to be inexcusable, and






Applications Completed* - Feb. 25




Applications Completed - Feb. 25

Service by Geographic Location - Feb. 25




