Maximum dimensions allowed and travel restrictions on an annual oversize permit are:

- 120' long x 12' 5" wide x 13' 10" high - unlimited distance - no routing required
- 120' long x 14' 6" wide x 15' 5" high - movement restricted to 50 miles radius unless the route continues on at least 4-lane roads or trip routes are obtained above.
- 120' long x 16' wide x 15' 5" high - trip routes must be obtained
- 75' long x 12' 5" wide x 14' 6" high - maximum dimensions for hauling hay

Carrier will be responsible for obtaining necessary route approval prior to move. [Black Hawk County Bridge Embargo Map](#) and [www.511ia.org](http://www.511ia.org) should be used to obtain information for self-routing.

Permits can be issued only for transporting single articles that exceed statutory size limits unless the inclusion of additional articles does not cause the size or weight to further exceed the statutory limits.
